3. Irrevocability:- The Trust hereby declared, shall not be revocable at the instance of the 'Author of the Trust' at any time and under any circumstances. Thus, the Trust hereby created is irrevocable.

4. Objects:- The aims and objects of the Trust shall be:-

- a) To provide or assist in providing for food, clothing and financial assistance to the poor and needy without any distinction of any caste, creed and religion and to afford relief to people in distress and adopt children affected by earthquakes, floods, famine and other such causes and to grant donations for the support of the inmates of orphanages, rescue houses and similar institutions and societies.
- b) To establish and/or maintain hospitals, dispensaries, clinics maternity homes, etc., to conduct medical camps, eye camps, blood donation camps, etc., to provide facilities or assistance for treatment of the physically and mentally challenged persons and those suffering from terminal illness and distribute medicines free of cost or at concessional rates to the poor and needy.
- c) To establish, maintain, run, develop, improve, extend grant, donate for the benefit and to aid and assist in the establishment, maintenance, running, development, improvement and extension of educational institutions, technical, medical, industrial and in other fields including schools, colleges, polytechnics and research associations and institutions, workshops, etc., without any bar or limit.

- d) To aid, establish, maintain and run hostels for the benefit of students, housing and other accommodation for teachers and other staff, homes for the aged and handicapped, and dharmashalas for the general public.
- e) To purchase, take on lease or hire, acquire, establish, maintain, run, develop, improve, extend and/or grant donations; take donations, for and to aid and get aid for the establishment, maintenance, running, development, improvements and extension of libraries, reading rooms, laboratories, recreation centers and other facilities as are considered to be of use in imparting education for general public or to the student population in particular.
- f) To give scholarships, stipends, loans, awards, prizes and other monetary assistance for the purpose of study, research and apprenticeship to the students and scholars and to give grants and donations to the poor and needy students for procuring their school uniforms/dresses or for purchasing textbooks, note books, instruments or any other learning aids.
- g) To erect, construct, acquire, establish, promote, setup and manage or to assist in erecting, establishing, acquiring, promoting or setting up training centers, hostels, educational institutions, infirmaries, orphanages, destitute homes, houses for widows and aged persons.
- h) To construct, maintain and manage meditation centers, schools of yoga, sports or physical education, Vedic schools and such other institutions.

**5 Funds and Properties** The Trust property shall consist of

- a) The initial fund of Rs.10,001/- (Rupees Ten Thousand One only) dedicated by the 'Author of the Trust' and transferred to the Trust shall be the nucleus of the Trust
- b) Contributions, donations, gifts, endowments, income and other amounts received by the Trust from time to time shall constitute the property of the Trust.
- c) Properties, movable and immovable, acquired by the Trust by transfer, taking over, assignment, purchase, gift, donation, entrustment, exchange, hire, mortgage, and lease or by any other mode.

**6. Application of Funds and Properties:** The Board of Trustees shall apply the income of the Trust and its properties, assets, effects, funds, etc., which vest in the Trust perpetually and irrevocably for the due fulfillment and effectuation of the objects and purpose of this Trust and no part of it shall be utilised for payment of any dividend or profit to the trustees or any other person

**7 Constitution and Management:-**

- a) The first trustees mentioned hereinabove shall be collectively and compendiously referred to as the 'Board of Trustees' and all the funds, properties, rights, claims and demands of every description belonging to or pertaining to the Trust and which may be acquired by the Trust from time to time shall vest in the 'Board of Trustees'.
- b) The first trustees mentioned hereinabove viz., Sri R.Srinivas and Smt. S.Girija shall be the trustees of this Trust, for life.
- c) The 'Board of Trustees' shall have the power to appoint additional trustees subject to a maximum of Nine Trustees at any given point of time. The Board of Trustees shall also have the power to fix the terms of appointment and the tenure of the trustees so appointed.
- d) The life trustees shall have the power to nominate their successors
- e) If in case, any of the permanent trustees resign his or her office without appointing any nominees, then the 'Board

of Trustees' may appoint any other person as trustee in place of the person so resigning.

f) The Trustees shall be respectively chargeable only for moneys or securities as they shall respectively actually receive not withstanding their respectively signing any receipt for the sake of conformity and shall be answerable and accountable only for their own acts, receipts, neglects or defaults and not those of each other, nor of any Banker, Auctioneer or other persons with whom or into whose hands any Trust moneys or securities may be deposited or for insufficiency in title or difference in value or investments, nor for any other loss, unless the same shall happen through their own willful default respectively.

g) The Board of Trustees may from time to time frame, alter, amend, modify or delete any rules and regulations or Bye-laws with respect to meetings, quorum or such other procedural matters as may be necessary to implement the objects of the Trust and such Rules and Regulations shall not be repugnant to the Trust Laws and any other law that may be applicable to the Trust.

8. Powers of the Trustees: Without prejudice to the generality, powers vested in them for achievement of the objects of the Trust, the 'Board of Trustees' shall have the following specific powers:

- ✓ a) To acquire by purchase, gifts, grant, exchange, mortgage, lease or otherwise, properties of all kinds, both movable and immovable and to convert one kind of property into another.
- ✓ b) To improve or to add to the corpus of the Trust.
- ✓ c) To sell, lease out or give on licence or otherwise dispose of or alienate, all or any of the properties of the Trust.
- ✓ d) The trustees may in their discretion permit non-trustees and members of the public at large to contribute to the corpus of the Trust on such terms and conditions, as they may deem fit and necessary from time to time.
- ✓ e) To do, cause or undertake any activities that would generate income required for achieving the objects of the Trust.
- f) To borrow for the purpose of the Trust on personal credit of the Trust with or without charge and responsibility upon

the assets of the Trust whether from the bankers of the Trust or any other persons under such terms and conditions as they may agree upon from time to time.

- ✓ g) To institute, prosecute, represent or cause to represent and defend all actions and proceedings, and the like before the Government, Semi-Government, Courts, Tribunals, Revenue, Municipal and Local Authorities, Tax Authorities, Universities (Educational/other), etc.
- ✓ h) To sign and verify pleadings of all kinds, enter into compromise, abandon or refer to arbitration whole or any part of the claim by or against the Trust, to engage the service of lawyers, pleaders, advocates or any other person/s as the trustees may deem fit and to terminate their services and also alter the terms of their service.
- ✓ i) To engage and employ such professors, teachers, doctors, etc., as they may in their discretions think fit, for performing the objects of Trust on such salaries or pay as they think fit and shall also be entitled to suspend and remove them and in their place appoint others. The trustees shall also employ other servants if they think necessary for attending to the day-to-day affairs and maintenance of the Trust.
- ✓ j) To engage the services of Chartered Accountants, Tax Consultants, Architects, Engineers, Contractors, Carpenters, and other staff or professionals for the purpose of the Trust and pay them such remuneration as may be found necessary.
- ✓ k) To incur all the costs and expenses for the due creation, execution and efficient management of the affairs of the Trust and properties of the Trust.
- ✓ l) To open and maintain the accounts of the Trust in any Bank of their choice and to authorise operations of the said account by any of the members of the 'Board of Trustees' as the case may be for the time being in force.
- ✓ m) To invest the Trust funds in any form or mode provided that the investments shall be only in forms and modes authorised by section 11(5) of the Income-tax Act, read with Section 13(1)(d) of the said Act, as amended from time to time.

- n) The 'Board of Trustees' shall have the power to appoint and constitute any committees or sub-committees for the purpose of facilitating better administration and management of the Trust, its corpus and for the purpose of the accomplishment of the objects of the Trust. That the persons who have been appointed as members of such committees or sub-committees shall hold the office as members for such period as may be determined, the 'Board of Trustees'. The decision and suggestions of such committee or sub-committees shall only be advisory in nature and shall not be binding on the trustees or the 'Board of Trustees'. The members appointed to such committees or sub-committees shall not interfere with the day-to-day affairs or administration of the Trust.
- o) To add or alter or abrogate or modify any of the provisions of this Deed of Trust, provided that such amendment, addition or alteration shall not be repugnant to the provisions of Section 2(15), 11, 12, 13 and 80G of the Income-tax Act, as amended from time to time provided further that no such amendment shall be carried out without the prior approval of the Commissioner of Income-tax having jurisdiction of the Trust.

All or any of the aforesaid powers may be exercised by the trustees who constitute the 'Board of Trustees', jointly or severally, as the 'Board of Trustees' may determine from time to time.

#### 9. Duties of the Trustees:-

- a) To manage and administer the day-to-day affairs of the Trust and its corpus.
- b) To maintain or cause to maintain proper and correct accounts in respect of all the transactions of the Trust and its funds.
- c) To do or cause to do all such other things, acts and deeds as may be necessary for the proper management of this Trust.
- d) To inform and advise the Board the various actions that are necessary to be taken from time to time for accomplishment of this Trust and to manage and safeguard the funds of the Trust.

e) The trustees shall not carry on any business either directly or indirectly using Trust property and income, prejudicial to the interest of this Trust.

10. **Remuneration of Trustees:-** The office of the trustees shall be honorary and the trustees shall not be entitled to draw any remuneration of whatsoever nature for carrying out their duties.

11. **Benefits:-** The benefits of the Trust shall be made available to all persons irrespective of caste, creed, religion or nationality, by the Trustees through specific resolutions passed from time to time concerning each situation as and when it arises.

12. **Indemnity:-** The 'Board of Trustees' shall be wholly indemnified or reimbursed against any expenses and losses incurred or suffered or any payment made by them in good faith and in the bonafide administration of the Trust and such expenses, losses and payments shall be borne by the Trust and none of the trustees shall be personally liable or responsible for the same.

13. **Accounts:-** The 'Board of Trustees' shall maintain or cause to maintain proper and correct books of accounts in respect of all the sums of money received, paid, expended, invested on behalf of the Trust and of all the Assets, properties and Liabilities of the trust. The books of account so maintained and the balance sheet as at the last date of every financial year (i.e., 31<sup>st</sup> March) shall be subjected to audit by a Chartered Accountant, who shall be appointed by the 'Board of Trustees'.

14. **Dissolution:-** In the event of dissolution or winding up of the Trust for want of its objects having become impossible of performance, all the properties of the Trust shall be transferred to another Trust or Institution having similar objects which is registered u/s12A and 80G of the Income-tax Act as amended from time to time. The Trust properties shall not be distributed amongst the trustees or other persons or Government body under any circumstances.
